ELIGIBILITY CRITERIA:

Applicant must be a dependent child under the age of twenty-two (22) of an active, retired, or deceased Nevada NALC Member.

Applicant must be at least a high school senior entering an institution of further learning or presently attending or intending to attend an accredited college or trade school.

Application must be submitted on the form provided in the Nevada Letter Carrier (or a photocopy thereof).

REQUIREMENTS:

Applicants must show proof of acceptance to an accredited college or trade school.

Applications must be received before June 17, 2021.

Applicants must receive the endorsement of the President or Secretary of the branch in which they claim eligibility.

REGULATIONS:

The goal is a minimum of five \$1,000.00 scholarships awarded.

The funds shall be made payable to school with a copy to student.

The Scholarship Committee Chairman shall review all applications to assure that all criteria have been followed and the requirements have been met.

Failure on the part of the applicant to meet the rules may be subject to disqualification. The decision of the Scholarship Committee shall be final.

Prior scholarship winners shall not be allowed to re-apply in future scholarship campaigns.

The Scholarships shall be awarded by random drawings of all eligible applicants.

This drawing shall be held at such time as selected by the committee.

An appropriate notification and certificate will be presented to the winners by an officer of the Nevada State Association.

If the scholarship is not used within 1 year from the time of its award, those funds shall revert back to the scholarship fund. Moneys not awarded shall remain in the scholarship fund.
